

Terms & Conditions for Trout Territory Guided Trout Fishing Tours in Tasmania

Prices:

All prices quoted by Trout Territory are in Australian Dollars and include Goods & Services Tax (GST). The rates provided are for the guided fishing component of the package only, and does not include meals other than lunch and refreshments provided on guiding days. This rate may be subject to change at any time by the operator. All prices quoted in response to enquiries are valid for 60 days.

Deposit:

A 20% deposit will secure your preferred booking date. Full payment is due at the commencement of the tour.

Payment Methods:

There are three convenient payment options to choose from:

Angling Licence:

It is illegal to carry out fishing activities on Tasmania's inland waters without a Tasmanian Angling Licence. Licences are available for purchase from authorised agents including tackle shops and Service Tasmania. Trout Territory is an agent that is authorised to sell Tasmanian Angling Licences and these can be purchased from the tour guide at commencement of the tour. Tasmanian Angling Licences are charged at rates specified by the Inland Fisheries Service. 2009-2010 IFS license prices are: • 48 hour \$19.50 • 7 day \$33.00 • 28 day \$51.50 • Full season \$65.00. Junior and senior discounts apply.

Transport:

Unless otherwise specified, transport is included in the guided tour rate on tour days only, and includes pick-up and drop-off from Launceston Airport or accommodation in Launceston or Cressy/Longford and surrounds area or the Central Highlands, to angling locations in the northern lowlands and the Central Highlands. Transport on non-guided days may incur a charge and is subject to our availability. Pick up from other areas – P.O.A. Any transport other than agreed in the quotation may also incur a charge. Prices do not include travel to or from or within Tasmania outside of the above mentioned criteria or any other transport arranged separately by you.

Accommodation:

Accommodation is not included in the guided fishing rates. If you would like accommodation to be part of your package, please let us know and we can arrange it for you. For your convenience we offer an accommodation booking service for a small fee of \$20.00 plus the room rate. Please talk to us about your requirements.

Cancellations of bookings made directly with Trout Territory where a deposit has been paid:

More than 28 days prior to commencement of tour, all deposits will be refunded. 28-8 days prior to commencement of tour, 50% of deposit will be refunded. 7 days or less prior to commencement of tour, 20% of deposit will be refunded. The terms, conditions & cancellation policy are different for corporate bookings. Deposit may be transferred to secure another date where available. Please read section Corporate Bookings in these Terms and Conditions.

Corporate bookings:

If we consider your enquiry to be of a corporate nature we notify you of this. The following terms, conditions and cancellation policy apply to all corporate bookings.

Corporate bookings terms, conditions and cancellation policy: Deposit must be paid via Visa or MasterCard in order to secure the booking. Full payment is required 14 days prior to the date of tour/activity and will be debited from the credit card number supplied for the deposit unless another credit card number is specified beforehand. By paying a deposit you authorise this credit card debit for the balance of payment. You will be notified of this debit via email. No refund is given for participants that do not attend on the day of the tour/activity.

Cancellation of corporate bookings made directly with Trout Territory where a deposit has been paid: More than 30 days prior to the commencement of tour/activity, all deposits will be refunded. 30 – 15 days prior to commencement of tour, 20% of deposit will be refunded. 14 – 8 days prior to the commencement of tour, 50% of all monies paid will be refunded. 7 days prior to the commencement of tour, no refund will be given.

Cancellations of bookings made via the online "book now" facility, where the tour has been fully paid for:

More than 28 days prior to commencement of tour, 70% of payment will be refunded. 28-8 days prior to commencement of tour, 50% of payment will be refunded. 7 days or less prior to commencement of tour, 100% of payment will be retained by the operator.
